Suffolk County Council Budget Agreed – The Council at its February meeting announced a budget of £597.9million - an increase of £41million (7.4%) on 2020/21. About £15m is allocated to ongoing pandemic responses. Council tax will increase by 3.99% of which 2% is dedicated to social care. Plug In Suffolk - is now providing grants for the installation of Electric Vehicle charging points at non-profit locations such as community centres, parish council car parks and village halls.
