1. Chairman's opening remarks

Cllr Burn welcomed all those present.

PUBLIC FORUM

There were no members of the public present.

District Councillor Burn gave a brief report including details of Stuston Parish Council change in status to a Parish Meeting.

2. Apologies for absence

3. Councillors' Declarations of Interest

Councillors were reminded of the requirement for them to individually update their Register of Interests as appropriate.

4. Approval of minutes of meeting of 3 November 2014

The minutes of the meeting of 3 November 2014 were unanimously agreed and were duly signed by the Chairman.

5. Matters arising from minutes of meeting of 3 November 2014

461/5 + 461/9 – Cllr Garrett had made contact with Suffolk Police regarding the placement of speed data recorders. 461/8d – Telephone kiosk. Clerk to check if repair had taken place. *Action: Clerk*.

461/9 - Common Committee to meet and progress work at the embankment. Action: Cllr Conroy

6. Procedural

- a) 2015 Annual Parish Meeting it was agreed that the Meeting would take place on Friday 24 April with refreshments being served. Parishioners would be encouraged to attend and possibly bring along any historic photographs of the parish. This concept would be discussed with the Village Hall Association at a planned future meeting to ascertain if they would like to be involved with the refreshments. - b) May 2015 Parish Council Elections Cllr Burn confirmed that he would not be standing again at the May elections. The Clerk gave details of the planned issue of nomination packs as advised by the District Council.
- c) <u>Dedicated Thrandeston Parish Council email addresses</u> for individual Councillors Cllr Burn and Conroy already had Parish Council email addresses, Cllr Garrett would like a dedicated address but Cllr Mortlock and Stebbings would keep their personal email addresses. *Action: Cllr Burn to send details to Cllr Garrett.*
- d) On-line presence for Thrandeston Parish Council the need to publish information on-line, particularly in light of the new Transparency Code, was discussed. It was agreed to approach One Suffolk about the possibility of a website for Thrandeston Parish Council. The Parish Council remained committed to providing information for publication on the existing Thrandeston.org website. Action: Clerk to contact One Suffolk, copying Cllr Garrett and Cllr Conroy.
- e) <u>Minutes of Parish Council meetings</u> a parishioner had asked to receive copies of Parish Council minutes. It was agreed approved minutes would be published on the Thrandeston.org website and the One Suffolk website once this was active.

b) Work (drainage) to Village Hall Car park (minute 457/9 refers) - Cllr Conroy had spoken with Natural England about the possibility of a ditch to carry away the water that collects in the car park area. A ditch would cost less and be easier to maintain than a pipe which had already been discussed. Action: To be progressed by the Commons Committee.

9. Planning Inspectorate Examination - Proposed Gas Power Station

Cllr Burn gave a summary of the last hearings which were held on 9/10/11 December 2014. The issue specific hearings on 10 and 11 December had focussed on the ancient field system in Yaxley (where the planned substation would be located) and the adverse impact on setting of built heritage. Written summaries were then submitted and the last opportunity to comment would be 13 January. The examination process would close on 24 January and a decision would be made within six months.
